President's Message

My last article dealt with how ECHO helps people stay in their homes while they are experiencing a crisis. It is the goal of ECHO to keep people housed, fed, and secure. Unfortunately, there are times when people do lose their housing. Rock County is in an affordable housing crisis and it can feel hopeless. ECHO has been working to create more affordable housing, yet we cannot meet all of the needs of our community. ECHO is very fortunate to have two Housing Resource Navigators, whose full-time jobs are to locate housing and provide resources for those who lack those resources. Riley and Denise are available to help their clients get back into permanent homes and stay there.

These grant-funded positions offer our neighbors access to assessments that determine what their housing barriers might be. This program also provides a personal connection to our navigators, who learn their preferences and help them develop an action plan. Riley and Denise also support our clients by mentoring and assisting in finding the resources, programs, and services that are available. No two meetings are alike, as each client's needs vary. If a client needs assistance filling out applications, or visiting with potential landlords; Riley or Denise is right there beside them, giving them the support they need. There is also an educational component that goes along with this: teaching communication skills, time and/or money management and other crucial survival skills. Riley and Denise take pride in helping their clients obtain housing through the programs ECHO offers. They are also aware of other resources and services within Rock County that might cover some situations that ECHO does not. In those instances, our clients are guided toward those solutions. Once housing is found, ECHO can assist with emergency rental assistance, which either pays the security deposit or the first month's rent.

Helping our clients begins long before the client walks through the door. Riley and Denise conduct outreach to inform area landlords about our programs and to build rapport. Those regular visits help keep landlords aware of the housing needs of our clients and assure the landlords that our clients are striving to become reliable renters supported by ECHO. They also make frequent phone calls to the landlords to see if any openings have occurred. It is important that they develop a good relationship with landlords to encourage collaboration. This way if a problem develops, the landlord feels comfortable contacting us and knows that we will do our best to help our clients solve it before it becomes an eviction.

Executive Director's Message

Over the last couple of ECHO newsletters, you have seen a theme around housing and homelessness. The housing (owner and rental) inventory has decreased, and the price of housing has increased due to inflation and demand. ECHO has seen an increase in requests for all our housing and homeless programs because of the low inventory and the increased rental rates. Today, I will focus on our Transitional Living Program (TLP). In 2019, we partnered with the City of Janesville's Neighborhood and Community Services department (NCS) to start our TLP with the donation of a house through their tax

foreclosure program. NCS also provided funding to help rehabilitate the house into safe and sanitary conditions. The doors to that TLP home opened to the first homeless family in March 2020.

The mission of ECHO's TLP is to provide support for homeless families to establish independent lives and move from homelessness to permanent housing. The TLP provides up to 18 months of weekly case management and housing to qualified households. The program's case management includes advocacy, supportive services, and crisis services. To help families along on their journey, participants will also be required to set and progress on long- and short-term goals. Some goals for the adults in the household could be to continue their education or participate in job training programs to obtain better paying employment, obtain their driver's license and/or vehicles to get to work and other appointments, work on improving their credit scores, and creating, and sticking to a monthly budget. The whole family could get connected to medical services (physical and/or mental health). Tenants will be provided individualized case management that is designed to help them obtain income and to prepare them to become renters in a market rate rental unit after the program ends. As necessary, ECHO will assist participants with accessing different services such as FoodShare, W-2, Social Security, and more.

As mentioned in past articles, by the end of 2024 ECHO will have eight units available for our transitional living program. ECHO invites you to join us in celebrating the opening of our second TLP home as we host an open house and celebration at the 4th Ward Park on Tuesday August 20, 2024, from 5:00-7:00pm. We will have kids' activities at the 4th Ward Park that is right across from our new TLP home on S. High Street. Tours will be available for those who would like to see the rehabilitated house. More information on the open house and celebration can be found on our website and social media accounts.

For a refresher, the second home was also donated by the City of Janesville's NCS, along with funding to rehabilitate the house that was vacant for over five years. The additional \$50,000 that was needed to bring it up to a safe and sanitary condition was provided by a matching grant through the Janesville Foundation and generous friends of ECHO. We greatly appreciate everyone's support of this project financially. We would also like to thank the Brothers Main and Hallman Lindsay for the support of this home through discounts and/or donated product.

This program is an important part of ECHO's future as we continue to provide a hand up, not a handout, to our low-income clients and families experiencing homelessness. These TLP homes provide a private, safe, stable place for them to decompress from past trauma while working on short-and long-term goals that will help remove barriers to self-sufficiency. We encourage you to connect with us to learn more about the transitional living program and how you can help this program continue to expand while meeting a critical need in our community.

June 22 Tornado Relief Grant Program

On the evening of Saturday, June 22, a reported tornado touched down in multiple areas of Rock County. This weather event caused considerable damage to structures and infrastructure.

The County has activated its Emergency Operations Center to mobilize additional resources. As a part of this response, ECHO is coordinating the reception of financial donations to those impacted.

Individuals and organizations interested in making financial donations may drop off cash or checks at ECHO, Inc. at 65 South High Street during regular business hours.

Those affected by the tornado can apply for a one-time grant up to \$500 to help cover recovery efforts. Applicants' household income must be at or below 80% County Median Income and in an area of reported tornado touch down.
