THE BYLAWS MAY BE AMENDED AT ANY TIME BY A VOTE OF TWO-THIRDS OF THE MEMBER REPRESENTATIVES AT A MEETING WITH A QUORUM DULY CALLED FOR THAT PURPOSE, PROVIDED THAT THE PROPOSAL FOR SUCH AMENDMENT WAS SUBMITTED IN WRITING AT THE PREVIOUS REGULAR MEETING AND THAT WRITTEN NOTICE HAS BEEN SENT TO ALL MEMBERS.

THE BOARD TREASURER OR PRESIDENT SIGNS THE FORM.
